

2024 YEAR IN REVIEW

Oh! What a year it has been!

The clients continue in their usual routine activities, which includes daily living skills that improve and support their mental wellness. They carry out cleaning of the facility and they also maintain the property on a daily basis, doing household chores and also collecting breads from the bakery etc.

Since January we have had 2 new admissions with 2 clients being rehabilitated.

CUMI provides breakfast and lunch and we serve approximately 380 meals per trimester.

While at CUMI, the clients' daily prescription routine and clinic visits are overseen. Every client receives an evaluation and follow-up for mental health at the Type V Health Center, the Cornwall Regional Psychiatry Clinic or the community satellite clinics.

For clients and family members who require ongoing counselling, instruction regarding the use or the taking of medication and its impact on the clients' mental health there is a volunteer psychologist who visits up to 3 times per month on occasions. We also now have a volunteer occupational therapist available.

CUMI concentrates on every aspect of the clients' wellness. In light of this, different Church groups such as The Church of Jesus Christ and The Burchell Baptist Church visit twice per month to engage the clients in social activities and also host devotion. They also serve breakfast and lunch on specific days of the month.

CUMI also hosts visiting institutions that gives health talks and give gifts to the clients. One of which is The National Council on Drug Abuse; their psychologist also visits CUMI twice monthly to give counselling to clients who still struggle with smoking habits.

Our 2024 Tryall CUMI Charity Golf Tournament was a huge success. Our target was exceeded and everyone had a good time.
